COMMENTS FROM THE REGISTRAR GENERAL



The Annual Report for the year ended December 31, 2015 is prepared in accordance with Section 19 of the Registration (Births and Deaths) Act 1949. In full recognition of the role of the Registrar General in the compilation of vital statistical information and the important role that this plays in planning for the provision of services in areas such as education, health and housing, to name a few, I have taken the necessary steps to ensure that the highest quality is maintained in the recording, collating and presenting of the data to be included in the Annual Report.

This Annual Report is concerned principally with vital statistics in respect of the resident population of Bermuda. The Annual

Report seeks to provide an illustrative statistical digest of vital events such as live births, deaths, foetal deaths (stillbirths), marriages, adoptions and re-registration of births.

In the preparation of this report, I have relied on information received from the Records Office of the King Edward VII Memorial Hospital relating to births; from the local funeral directors and medical practitioners in relation to deaths and from local marriage officers and Masters of Bermuda registered ships in relation to local and maritime marriages respectively. The occurrence of sudden deaths is reported to the Registrar General by the Coroners' Office and Officers of the Magistrates' Court are responsible for informing the Registrar General of adoptions that take place on the Island.

The population estimates for the year ended December 31, 2015 are based on the 2010 Census figures. The excess number of live births over deaths for each year since then has been added to the base figures to compute the population statistics. No consideration has been given to the effect of emigration or immigration on the population.

I acknowledge the expertise and commitment demonstrated by my staff in the provision of vital registration services in 2015 and hereby submit my Annual Report for the year ended December 31, 2015.

GENERAL INFORMATION

Births

The Registrar General is notified by the King Edward VII Memorial Hospital Medical Records Department of the births of children born there on a weekly basis. When a child is born at a location other than the hospital, notification is made by the person or persons who attended the birth.

For the year ended 31st December, 2015 the total number of live births recorded in respect of residents was 583; an increase of 9 or 1.6% from the 574 births recorded in 2014.

The live birth rate of the population increased by 1 point per thousand from 8.8 points recorded in 2014 to 8.9 points in 2015.

The number of births that occurred out of wedlock in 2015 increased by 6.7% points from the percentage of out of wedlock births for the previous year. The out of wedlock distribution of births occurring during the five-year period 2011 to 2015 ranged from a high of 45.6% in 2015 to a low of 38.9% in 2014.

Deaths

The Registrar General receives notices of deaths occurring on the Island and within Bermuda's territorial waters from local funeral directors. The notices of deaths are sent to the Registrar General by the Coroners' Office in cases where inquests have been held into the causes of deaths.

A total of 466 deaths were recorded for the year ended 31st December, 2015. This figure consists of 457 deaths of residents and 9 deaths of non-residents. The number of stillbirths remained at two for the 2015 year.

A death rate of 7.0 per thousand of the population for 2015 reflects a decrease from 7.3 recorded in 2014.

Marriages

The Registrar General received information pertaining to marriages celebrated on the Island from local marriage officers. Information in respect of marriages that take place on the high seas aboard Bermuda registered ships is provided by the Masters of those ships.

There were 509 marriages performed in Bermuda for the year ended 31st December, 2015, a 6.7% increase from the 477 marriages recorded in 2014. Out of the 509 marriages, 272 or 53.4% of the marriages took place between parties who were both non-residents; 194 or 37.5% of the marriages between parties who were both residents and 43 or 4.4% of the marriages between a resident party and a non-resident party. There was a 0.7% decrease in maritime marriages recorded in 2015 when comparing 565 marriages to 569 maritime marriages recorded in 2014.

Resident Population


There was an increase of 126 or 0.19% in the estimated resident population at the end of 2015 at 65,313 as opposed to the 64,187 in resident population estimate in 2014. At the end of 2015 there were 2,713 more females than males in the population figures. (See Table 1.0)

The average increase in population over the past five years is 173 persons.

The statistics compiled by the Registry General do not take into consideration any effects on the population due to emigration or immigration.

BIRTHS

Distribution of Live Births by Sex and Natal Status - 2011 to 2015

In 2015 the total number of live births of 583 births reflects a slight increase of 9 or 1.6% over the previous year. The live births in respect of residents recorded in 2014 were 574. Out of the total number of live births recorded in 2015, 295 were male and 288 were female. In 2014, 289 male and 285 female live births were recorded.

There were five babies born at the parent's homes in Devonshire, Paget, Pembroke and Southampton parish. This is a decrease of 1 from the six babies born at home in 2014.

The total number of births for the year 2015 born out of wedlock was 266, an increase of 43 from the previous year. A cumulative total of 3,126 live births were recorded for the five-year period from 2011 to 2015. The overall percentage of live births occurring out of wedlock was 45.6% with a median rate of 42.4% over the same five-year period.

Distribution of Live Births by Parish

The majority of babies are born at the King Edward VII Memorial Hospital in Paget parish. However, for the purpose of this Report, the statistics shown in Table 2.1 below, relate to the parishes of residence of the mothers of the new-borns at the time of birth and not to the parishes where the babies were actually born. The highest number of births by parish out of an island-wide total of 583 was recorded among the residents of Warwick parish who were responsible for 95 or 16.3% followed by the residents of Pembroke parish who were responsible for 86 or 14.8% of the total number of births recorded.

Table 2.1 shows the distribution of births by sex, natal status and parish.

Multiple Births

The record number of sets of twins born in a single year continues to stand at 19 for the year 2013. In 2015, the number of sets of twins born remains at eight, which is a decrease of 11 from the 19 recorded in 2013. Four sets consisted of both female children, two sets of both male children and two sets of one male child and one female child out of the eight sets of twins born in 2015.

Distribution of Live Births by Age of Mother

Women between the ages of 30 and 34 years continue to account for the highest number of the babies born in 2015 at 224 or 38.4%. This remains consistent with the figures over the past five years. For the period 2011 to 2015 women in the age group 35 to 39 years accounted for the second highest number of babies except in 2011 when women in the age group of 25 to 29 years held this honour. The two age groups (30 - 34 year olds) and 35 to 39 year olds) were responsible for 64.7% of the 2015 births. There were no babies born to a mother under the age of 16 in 2015, but in 2014 two babies were born to mothers under the age of 16.

Figure 2.0 shows the distribution of births by age of mother and natal status for the year ended 31st December, 2015. It can be seen from Figure 2.0 that married women between the ages of 30 and 34 years comprised the group responsible for the largest number of babies born.

Distribution of Live Births by Age of Mother and Natal Status – 2015



Distribution of Live Births by Nationality

It is important to note that the following statistics on the nationality of new-borns are compiled based on information provided by parents at the time of registration of their children's births.

There were 317 babies born in wedlock in 2015. 91 or 28.7% were born of parents who are both Bermudian; 124 or 39.1% were born of parents who are both non Bermudian; and 193 or 60.9% were born where one of the parents is Bermudian and the other a non-Bermudian.

There were 266 babies born in 2015 out of wedlock, 220 or 82.7% have parents who are both Bermudian; 22 or 8.3% have parents who are both non Bermudian and 24 or 9% have one Bermudian parent and the other a non-Bermudian.

Children with two non-Bermudian parents account for 146 or 25.0% of the total number of births in 2015, as compared to the 133 or 23.2% of the total births in 2014.

Over the five year period, 2011 to 2015, the percentage of children born to parents who were both Bermudian ranged from 49.8% in 2014 to 53.3% in 2015 with a median rate of 50.8%. For this same period the percentage of children born to one Bermudian parent and one non Bermudian parent ranged from 75.0% to 77.3% with a median rate of 76.4%.

Table 2.4 reflects the distribution of these births for the years 2011 to 2015.

The nationalities of the non-Bermudian parents, gathered for statistical purposes, represent over 40 different countries. The most frequently identified countries continue to be Canada, Great Britain, the United States of America, Jamaica, India, the Philippines, and South Africa.

ADDITIONAL VITAL EVENTS

Re-registrations

Re-registration is the process by which the births of children born out of wedlock are registered as if born in wedlock upon the marriage of their biological parents. In 2015 there were 3 re-registrations conducted in the Registry General.

Adoptions

In 2015 there were three adoptions recorded, an increase of one from the two adoptions recorded in 2014. All three adoptees were males. One was 16 years old, and the other two were both 17 years old.

Statistics Relating to Marriages – 2011 to 2015

Marriage statistics include all marriages taking place in Bermuda irrespective of the country of residence of the parties. There were a total of 509 marriages recorded for the year ending December 31, 2015, representing an increase of 32 or 6.7% from the 2014 figure of 477.

The number of civil ceremonies performed in the Registry General over the past five years totaled 586 or 21.7% of the total of 2,613 marriages recorded. The remaining 2,045 marriages were religious ceremonies held at places of worship throughout the Island and at other venues.

Table 3.0 provides a distribution of marriages by type of ceremony.

In 2014 there were 94 marriages performed in places of worship, 96 took place at the Registry General, and 287 marriages took pace at other venues.

Distribution of Marriages by Religion/Denomination

In 2015 there were 92 marriages performed in places of worship. Of those, 27 or 29.3% were held at Anglican churches on the Island; 65 or 70.7% were held at other churches throughout the island.

Marriage Venues

The Registry General conducted 118 civil marriage ceremonies or 23.2% of all marriages taking place in 2015. There were 92 marriages celebrated at places of worship identified in Table 3.2 below. Of the 299 marriages taking place at other venues, 150 took place in hotels, restaurants, guest houses or clubs; and a further 149 were performed in homes, gardens, parks, or on beaches and boats. 58.7% of the marriages performed in 2015 took place at locations other than places of worship or the Registry General.

Table 3.2 shows the distribution of marriages by parish and venue. Pembroke parish continues to record the highest number of marriages, primarily due to the high incidence of civil marriage ceremonies. Southampton, Warwick and Paget parishes also accounted for a relatively large number of marriage ceremonies due to the number of ceremonies conducted within their boundaries at venues other than places of worship.

Persons Marrying by Age Group of Partners

The largest number of persons who married in 2015 and 2014 is represented by the age group of 30 – 34 year olds. Two Hundred and twenty-eight, or 22.4%, of the total of 1,018 persons who married during 2015 were between 30 and 34 years of age.

Distribution of Marriages by Residential Status of Partners

During 2015 non-residents accounted for 272 or 53.4% of the total of 509 marriages taking place. This figure, representing a decrease of 1.1 percentage points over the previous year's figure, is in keeping with the trend over the past five years for marriages between non-residents to exceed the total number of marriages between residents and marriages between residents and non-residents.

DEATHS

Death Statistics Including Stillbirths – 2011 to 2015

The number of deaths of residents recorded in 2015 was 457; a decrease of 21 or 4.4% from 478 deaths recorded in 2014. There were two stillbirths recorded in 2015 and 2014.

Table 4.0 contains a breakdown of deaths over the period 2011 to 2015 by sex and stillbirths. The figures show that the total number of deaths among males exceeded that among females for the period. The number of still births recorded for the period ranged between 2 and 3 per year with an average of 2.2 over the five year span.

Distribution of Deaths by Age and Sex – 2015 (Excluding stillbirths and non-resident deaths)

Table 4.2 shows the distribution of deaths within various age groups as a percentage of the total number of deaths occurring in 2015 among the resident population.

Within the 85 - 89 year-old age group 84 or 18.2% of deaths occurred, followed by 69 or 15.1% in the 80 - 84 year-old age group out of a total of 457 deaths recorded. The number of women exceeded the number of men in the distribution of deaths between the sexes in the age groups 80 - 84 years as well as all age groups above 90 years. However, the number of deaths for men exceeds that of women for all age groups below 79, except age groups 35 - 39, 40 - 44 and 45 - 59.

Table 4.3 contains a breakdown of deaths by parish of residence of the deceased within specific age groups. Pembroke Parish resident's recorded 88 or 19.3% of deaths in 2015. This figure represents the largest number of deaths in a single parish for the total number of deaths recorded for the year.

Nine deaths were recorded in 2015 with respect to persons over the age of 100 years. Three of these decedents were resident in Pembroke. Paget, Warwick and Sandy's each had two decedent residents in their parish.


