

PREFACE

This publication presents a series of boundary description maps of Bermuda's 245 census districts. Census districts are the smallest geographic area for which census data is available and are derived from the former postal zone boundaries. Boundary description maps provide a high-level picture of the census districts with descriptive text. Each red box shown on the boundary description maps represents one section of the census district that is mapped as a detailed census district map. These detailed census district maps are available upon request as each census district may have several maps. The first number of each census district represents the parish to which it belongs, as follows:

- 3 Smith's
- 4 Devonshire
- 5 Pembroke
- 6 Paget
- 7 Warwick
- 8 Southampton
- 9 Sandys






Map of Bermuda by Census Districts, Part 2









1-010 Is indicated at its Western boundary in the South by the junction of Cut Road and Floral Lane; then North along Floral Lane to the coastline; then East along the coastline to Gates Fort; then West along Cut Road to the junction with Floral Lane. Hen Island is included in this census district.






1-020 Is indicated as its Western boundary by the East Municipal Boundary; the East boundary is outlined in the North by the junction of Barry Road and Floral Lane; then South along Floral Lane to Cut Road; then East along Cut Road to the South boundary of Gates Fort to the Sea. Islands in the Harbour including Smith's and Paget are to be included in this census district.







1-030 Is indicated as its Western boundary in the North by the Sea to the junction of Barry Road and Grenadier Lane; then South along Grenadier Lane to Old Military Road; then East and South along Old Military Road to Barrack Hill; then West along Barrack Hill and continuing West into Water Street to Kings Square. The East boundary is indicated by the East Municipal Boundary.







1-040 Is indicated as its Western boundary in the North by the junction of Slippery Hill and Kent Street; then South along Kent Street to Featherbed Alley; then West along Featherbed Alley to King's Square; then East along Water Street continuing up Barrack Hill to the junction with Barrack Street; then West along Barrack Street continuing along Slippery Hill to the junction with Kent Street.





1-050 Is indicated at its Western boundary in the North by the junction of Park Road and Park Gates; then South along Park Gates and into Queen Street to the junction with Chapel Lane; then East along Governor's Alley and continuing East through Slippery Hill and Barrack Street to Old Military Road; then North and West along Old Military Road to the junction with Park Road; then West along Park Road to Park Gates.






1-060 Is indicated as its Western boundary in the North by the Sea and Khyber Pass; then South along Khyber Pass to Suffering Lane; then East across the Golf Course into Park Road continuing East to Old Military Road; then along Old Military Road to Grenadier Lane; then North along Grenadier Lane over Barry Road to the Sea. All other boundaries are indicated by the shoreline.






1-070 Is indicated as its Western boundary in the North by the junction of Governor's Alley and Queen Street; then South along Queen Street to York Street; then West along York Street to Water Street; then South along the East entrance to Penno's Wharf; then East along the shoreline to King Square to York Street; then East along York Street to Kent Street; then North along Kent Street to Governor's Alley; then West along Governor's Alley to the junction with Queen Street. 





1-080 Is indicated as its Western boundary in the South by the junction of York Street and Old Maid's Lane; then North along Old Maid's Lane to Nea's Alley onto Printer's Alley; then North East along Printer's Alley to Turkey Lane; then North East along Turkey Lane to the junction of Turkey Hill; then East along Turkey Hill onto Queen Street; then South along Queen Street to York Street; then West Along York Street to the junction with Old Maid's Lane.







1-090 Is indicated as its Western boundary in the South by the junction of York Street and Khyber Pass; then North along Khyber Pass to the East junction of Suffering Lane; then East along Secretary Road across the Golf Course to Park Road; then East along Park Road to Park Gates; then South along Park Gates to junction of Turkey Hill; then South to Printer's Alley; then West along Printer's Alley to Nea's Alley onto Old Maid's Lane; then South along Old Maid's Lane to York Street; then West along York Street to the junction with Khyber Pass.







1-100 Is indicated as its Western boundary in the North by the junction of St. George's West Municipal boundary and Suffering Lane; then South along the Municipal boundary to the Harbour; then East along the shoreline to Penno's Wharf; then North along the East entrance of the Wharf to Penno's Drive; then West along York Street junction to Style Hill junction onto Khyber Pass; then North along Khyber Pass to Suffering Lane; then West along Suffering Lane to the junction with the West Municipal boundary.







1-110 Is indicated as its Western boundary in the North by the junction of the North shoreline and the West Municipal boundary; then South along the Municipal boundary to Suffering Lane; then East along Suffering Lane to Khyber Pass; then North along Khyber Pass to the Sea. The North boundary is indicated by the shoreline.







1-120 Is indicated as its Western boundary in the North by the junction of Wellington Back Road and the Railway Right of Way; then East along the Railway Right of Way to Wellington Street; then West along Wellington Street to Wellington Slip Road; then South along Wellington Slip Road to the Harbour at Wellington Slipway. The Eastern boundary is indicated by the West Municipal boundary.







1-130 Is indicated as its Northern boundary in the West boundary of Mullet Bay Park and Mullet Bay Road; then East along Mullet Bay Road to Wellington Slip Road; then South along Wellington Slip Road to the Harbour through Wellington Slipway.







1-140 Is indicated as its Eastern boundary in the North by the junction of Wellington Back Road and Railway Right of Way; then South along the Railway Right of Way to Wellington Street; then West along Wellington Street continuing West along Mullet Bay Road and the West boundary of Mullet Bay Park to the sea. The West boundary is indicated by a line drawn from Mullet Bay to North Shore over the East boundary of Sugar Loaf Hill.






1-150 Is indicated at its Eastern boundary in the North by the East boundary of Sugar Loaf Hill and includes all of Ferry Reach to its Western point; other boundaries are indicated by Severn Bridge and Swing Bridge. The most Western portion of St. George's approachable by land only via Coney Island Road and Ferry Island is to be included with this census district.







1-160 Is indicated as its Western boundary by a line running North from St. David's Road and into Higgs Bay forming the East boundary of the former U.S. Base; then East along St. David's Road to Chapel of Ease Road; then North along Chapel of Ease Road to the Sea. The Northern boundary is indicated by the shoreline.






1-170 Is indicated as its Western boundary in the North by Church Wharf and Chapel of Ease Road; then South along Chapel of Ease Road to St. David's Road; then East along St. David's Road to a point North of Blackwood Heights; then North along the shoreline.





1-180 Is indicate as its Western boundary in the North by Smith's Sound; then South in a line to St. David's Road; then East along St. David's Road to the junction with Battery Road; then West into Great Bay.







1-190 Is indicated as its Western boundary in the North by the junction of Great Bay Road and Battery Road; then South along Great Bay Road to the West boundary of Great Head Park; then continuing South along Great Head Park's West boundary to the Sea at the Southern boundary of Great Head Park. All other boundaries are indicated by the shoreline. Great Oswego and Little Oswego islands are included in this census district.






1-200 Is indicated at its Western boundary in the North by the junction of St. David's Road and Lighthouse Hill; then South along Lighthouse Hill and passing to the North of St. David's Lighthouse along Mount Road which leads to Sofar Lane; then South and East along Sofar Lane to the Sea. The Eastern boundary is indicated in the South by Cove Point; then North along the Shore to the Southern boundary of Great Head Park; then follows North along Great Head Park's West boundary into Smith Hill Drive to Great Bay Road; then West along Great Bay Road to St. David's Road.






1-210 Is indicated at its Western boundary in the North by the junction of St. David's Road and the East boundary of Southside; then South and East along Southside's boundary to Sofar Lane; then North along Sofar Lane and passing just North of St. David's Lighthouse into Mount Road; then North along Mount Road and continuing into Lighthouse Hill to St. David's Road.







1-220 Is indicated as its Western boundary by the Parish boundary line from Shark Hole in the North; then South to the Sea. The Northern boundary is indicated by a Parish boundary in the West at Shark Hole; then East to Castle Harbour. All of Tucker's Town, South and East of the Parish boundaries indicated.











9-200 Is indicated at its Northern boundary in the East by a line drawn East to West parallel with the North boundary of a house by the name of Seaforth and the Railway Trail; then West along a line and continuing into Somerset Road; then South along Somerset Road to a point in the South side of Scaur Hill and into the Sea; then continuing South along the shoreline to Somerset Bridge; then North along the shore-line to a line drawn parallel with the North boundary of Seaforth.




