This form is required by the Minister responsible for the Limited Liability Company Act 2016 (the "Act") for application under Sections 12 and 25 of the Act. For the meaning of expressions used in the form, such as "Bermudian", "Limited Liability Company" or "LLC", "Beneficial Owner", reference should be made to that Act. Reference should also be made to the Act in order to ascertain the requirements established for the grant of a licence for carrying on a business.
